The COVID-19 pandemic has forced many healthcare systems to adopt crisis practices that would normally be considered a compromise to usual standards of care. Strategies to address patient surge management and the allocation of scarce resources, such as Crisis Standards of Care (CSC) are policy, regulatory, and systems changes implemented when the duration of crisis care practices is prolonged. The U.S. Department of Health and Human Services' (HHS) Office of the Assistant Secretary for Preparedness and Response (ASPR) Technical Resources, Assistance Center, and Information Exchange (TRACIE) recently hosted [this webinar](#) where speakers discussed clinical consultation versus triage support, systems-level information sharing, coalition-level coordination activities, and recent publications/resources to help with planning efforts.
